The Council Crier Third Quarter 2022

The Quarterly Newsletter of the Virginia Council of Chapters of the Military Officers Association of America

Our Third Council Crier for 2022 tells the story of a highly active Virginia Council and Member Chapters, with the Legislative Advocacy and Community Service remaining prime examples of such engagement.

During the period 21 January - 4 August of this year, nine VCOC Chapter Teams conducted some 15 visits with our Virginia Delegation in advocacy of the MOAA top three legislative priorities. In measurable result, Virginia Delegation Co-Sponsors now numbers 13 for The Major Richard Star Act. This represents an increase of five cosponsors for 2021. The Star Act corrects the wrongful injustice of a veteran with a combat-related disability and fewer than 20 years of creditable service not being allowed to receive retirement pay, without reduction, concurrent with disability compensation.

The credit for the increased support for the Star Act belongs to the advocacy of our VCOC Legislative Affairs teams and leaders this year.

MOAA Advocacy in Action 2023 (AiA 2023) is scheduled for April 2023. AiA 2023 will be in person, Capitol Hill, Washington, DC. Standby for further details, to include specific AiA 2023 topics and schedule.

To State Legislative Affairs, Governor Glen Youngkin signed two bills this year of great significance to the Virginia Veteran. First, House Bill 957, patroned by Delegate Kathy Tran (D 42nd), which provides local governments the opportunity to offer tax relief for surviving spouses of a member of the Armed Services. Second, Senate Bill 528, patroned by Senator Bryce Reeves, R-Spotsylvania, and House Bill 1128, patroned by Delegate John McGuire, R-Goochland. The bills commence a state income tax deduction for military retirement income for veterans age 55 and older, phased-in rate of

\$10,000 in tax year 2022, \$20,000 in tax year 2023, \$30,000 in tax year 2024, moving to \$40,000 in the taxable year 2025.

The aforementioned bills remain living testimony to the advocacy efforts of the Joint Leadership Council, for which VCOC Third Vice President COL Monti Zimmerman, USAA (Ret) is Vice Chair. To HB 529, COL Zimmerman will continue work on a Constitutional Amendment, mandating Virginia county compliance with the Bill.

The 2023 Virginia General Assembly is scheduled to open on Sunday, January 8, concluding on Friday, February 24 (adjournment sine die is Saturday, February 25). Joint Leadership Council approved Legislative Initiatives, as of September 15, 2022, may be viewed at: Joint Leadership Council. To our VCOC advocacy with the General Assembly in 2023, COL Zimmerman has scheduled a Zoom Virtual Legislative Affairs Pre meeting for all Chapter Legislative Affairs Representatives, Monday, 19 December, 9:00am.

Kelly will become MOAA's President and CEO on Jan. 4, 2023, leading the nation's largest and most influential association of military officers. Commissioned in 1988, Kelly concluded his military career this year after serving most recently as the Air Force deputy chief of staff of Manpower, Personnel and Services at the Pentagon. "I'm extremely excited and proud," Kelly said. "It's a fantastic organization. What MOAA has been able to do in terms of legislative advocacy is really second to none."

Adm. James G. Foggo, USN (Ret) – Former commander of U.S. Naval Forces Europe and Naval Forces Africa, and U.S. Sixth Fleet. Served as dean of the Center for Maritime Strategy at the Navy League and member of the board of directors of the Olmsted Foundation, the Naval Historical Foundation and the Council on Foreign Relations.

A Perspective from Legislative Chair COL Monti Zimmerman, COL (Ret), USA

What is the value of MOAA? I have asked myself this question a lot over the past two years.

My initial and still strongest response is that it is the BEST advocate for military retired pay and benefit issues. We all know that the percentage of veterans is rapidly decreasing. Over the past two years, more than 2 million veterans have passed away. Also, from the statistics provided by the DoD Office of the Actuary, this is the first year that the total number of retirees has shrunk. The statistics that are presented for the prior fiscal year show the total number of military retirees shrunk from 2,003,957 as of 30 September 2020 to 1,996,446 as of 30 September 2021. The total number of officer retirees shrunk slightly, and the total number of veterans who served as officers rose slightly. I watch these numbers as it is important to remember we are but a small constituency in the greater schemes of Congress. With that said, on the recruiting and retention front, it is no secret that all services are struggling and the propensity for service of our young people is now only 9%.

Do you think that if we stop raising our voice and showing our flag that our positions will "magically" be supported by members of Congress and the 17% who have served in some capacity in the military? We have worked at the federal level with the Military Coalition representing 5.5 million veterans to finally, and with much effort get the PACT Act signed into law this August. Would that happen without MOAA? Maybe, but it would have been much more difficult. We should plan to be active on the Hill as we are close for Advocacy in Action in April 2023. On the state level, after a 25-year fight, the stars aligned to pass income tax relief. Additionally, we in MOAA on the JLC forced the Virginia Legislature to correct the wrong of oversight that did not provide for one of the most vulnerable groups, the surviving spouses of those who died on active duty, but were not killed by enemy. Now, we are trying to create a constitutional amendment that would create a permanent, across the Commonwealth benefit for this group, matching the benefit with those who are listed as 100% permanent and totally VA disabled and the surviving spouses of the 100% disabled group and to correct the benefit for the KIA Gold Star spouses as their benefit is not as generous as for the 100% disabled and their surviving spouses.

So, back to my question, the VCOC has power as we represent almost 2,000 officer veterans and retirees who have worked to retain and protect these benefits.

There is no other advocacy group that is focused on our issues. We are significantly stronger together that we would be separately.

In concert this article, our Council has launched the "Future of Councils" Committee, for which I am Chair. Our official meetings, via Zoom virtual, are scheduled to commence in January 2023, specific dates, times, goals and objectives forthcoming. A question that regularly comes up is; "What structure is the Virginia Council of Chapters, Military Officers Association of America" (VCOC) and is it the same as the Military Officers Association of America with headquarters in Alexandria, Virginia? Short answer is yes and no! What?

Lets start at the beginning:

The Virginia Council of Chapters, The Retired Officers Association, Inc. was initially formed on April 3rd, 1987. According to Virginia State Corporation Commission records, on March 1st, 2003 the Commission approved a requested name change, and

issued a formal Articles of Amendment on March 27th, 2003 with the new official name: Virginia Council of Chapters, Military Officers Association of America.

The Virginia Council of Chapters, Military Officers Association of America is an independent, nonstock corporation, licensed to do business in the Commonwealth of Virginia that must have its license renewed annually, and submit an Annual Report of its directors to the Virginia State Corporation Commission. The Virginia Council of Chapters, Military Officers Association of America is governed by its own set of approved By-Laws (voted and approved by the Chapter membership). These By-Laws are very similar to a company's Operating Agreement to shed some perspective. When issues come up from time to time, that are not be specifically spelled out and covered in the Chapter By-Laws, that matter/issue shall be governed under the Virginia Code of Virginia statues; Section 13-1 and its sub-sections. In fact, all Military Officers Association of America Chapters throughout the United States are independent, licensed organizations, each with their own set of operating By-Laws, rules and regulations.

Virginia Council of Chapters, Military Officers Association as a Chapter Organization.

A chapter-based organization is any organization that has branches in multiple areas and shares the same mission. This can include a variety of organizations, from sororities to professional associations to nonprofits, and they can be national, state-wide or regional.

Multichapter nonprofit organizations operate similarly to franchised businesses — which, if you've ever been to Dairy Queen or Denny's, you've experienced firsthand. Just like a for-profit business, the parent organization will copyright its name and create a licensing agreement with the chapter, who will then work to carry out its mission, find new members, and other day-to-day operations.

For the most part, chapter organizations are established under the umbrella of the parent organization. They will have their own board, and operate independently, while remaining their own entity. However, depending on the organization, the parent organization will want to have more or less say in the way these Chapter activities are handled.

Remember, since the parent organization takes on considerable legal liability for the affiliating Chapters, it's understandable that they would insist on adherence to their standards, mission and overall agendas.

MOAA Guidance On Partisan Political Activities

Partisan Political Activities: As organizations exempt from federal taxation under Sec. 501(c)(19) of the Internal Revenue Code, MOAA and its affiliates must take care to avoid engaging in partisan political activities. Under IRS rules, we are prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for public office.

Candidates for Public Office: A candidate for public office is an individual who offers himself or her- self, or is proposed by others, as a contestant for an elective public office, whether such office is national, state, or local, and includes incumbent candidates. The prohibition also extends beyond declared candidates and may apply to efforts to recruit an individual to run for office or advance exploratory activities. The prohibition also applies to advocating for the platform of one political party over another.

Prohibited Activities: Activities which constitute participation or intervention in a political campaign on behalf of or in opposition to a candidate include, but are not limited to, the publication or distribution of written or printed statements or the making of oral statements on behalf of or in opposition to such a candidate. It is clear that the prohibition on partisan political activity prohibits such outright actions such as posting a "Vote for Biden" or "Vote for Trump" on the organization's website, or "Support Republican Candidates" or "Vote Democratic."

In addition to these obvious examples, the prohibition goes well beyond direct expressions of support. In determining whether an organization is engaged in unlawful partisan political activities, the IRS applies a "facts and circumstances" test. The IRS looks not only to the expressed language, but to external factors, such as the communication's timing, its targeted audience, and how the message relates to public policy positions that distinguish a candidate in a campaign.

Consequences for Violations: The consequences to an organization that violates the prohibition on partisan political activity can be severe including the loss of its tax exempt status and the imposition of certain excise taxes. For public charities, like The MOAA Foundation and the MOAA Scholarship Fund, the IRS can disallow tax deductions for charitable contributions. In addition, for an organization whose mission involves advocacy on key military community issues, MOAA must seek support from elected representatives from both parties. Engaging in partisan political activities on behalf of one party or candidate would seriously undermine MOAA's ability to achieve the bipartisan consensus on key issues essential to achieving its legislative objectives.

Personal Opinions: As individuals, members and leaders of MOAA and MOAA's affiliates are not prohibited from engaging in partisan political activities so long as they do

so in way that makes it clear they are acting for themselves and do not appear to be speaking on behalf of MOAA or its affiliates. For example, it is permissible for an individual to express his or her personal preference in support of or in opposition to a candidate or political party. And they may do so publicly. However, when expressing their personal opinions or preferences, they may not make reference to their MOAA position, use MOAA communications channels, use MOAA letterhead or newsletters, identify themselves as MOAA leaders, or imply that MOAA or its members share their beliefs.
