**1. Administration**

**2. President's Report**

\* Col Boyd Nix, (USAF) (Ret) welcomed everyone. Thank you all for your work.

Special presentation by MOAA National Director, currently serving in Retired Affairs LTC Mark Belinsky, USA (Ret) introduction

MOAA Congressional top three priorities and the Star Act. Institutional storytelling to provide examples of MOAA relationships. #1 Toxic Exposure Reform: Agent Orange, Burn Pits, and other environmental impacts. #2 TRICARE Young Adult, fees have grown to exceed normal private healthcare and needs improvement. #3 Basic Needs Allowance is the concept to support junior service members with families that fall below the poverty line and have food insecurity.



The final initiative, but not an advocacy issues, is the MAJ Richard Star Act, named after the hero who passed away. This is about concurrent receipt. The total cost is \$33 billion over 10 years. In order to make it incremental, we are looking at those who were injured in a combat zone and forced to retire will cost \$6.9 billion over ten years. 45 co-sponsors in the Senate. ### **3. Treasurer's Report & Membership Report**

\* LtCol Jim Stephan, USAF (Ret) provided budget update.

- January 1, 2021 Balance Brought Forward \$7,100.58 minus MOAA Mileage Restricted Fund for mileage supplement \$882.64 leaves starting balance for 2021 at \$6217.94, on January 1 2020. Income from Chapter dues collected was \$1713.05 this quarter. A payment of \$325 in expenses for annual insurance was paid. The balance of \$8488.63 on 1 April with restricted funds of \$882.64 for MOAA Mileage Supplement leaves \$7605.99 in funds available.

Membership as of December 31, 2020 gives us a total of 2176 members in the VCOC. All Chapters have paid their dues. Next meeting should provide an accurate status of the chapter membership across the state.

### **5. Legislative Committee Report**

\* COL Monti Zimmerman, USA (Ret) reported on the Joint Leadership Council

(JLC) Legislative Initiatives for 2021. Only one new one was approved (no-fee license plated for Virginia National Guards members) and one from last year (the Constitutional amendment to provide a tax-free vehicle for 100% VA disabled veterans). Col Jim Pauls, USAF (Ret) will form a committee to support a counterpoint to the 2019 legislative report.
